Public Works Department Report

Roads/Storm

- Continued routine and pothole maintenance throughout town.

Wastewater

- UV/Headworks Enclosure project bids were received. The project will begin July 1st with an anticipated completion date of September 29, 2019.
- In conjunction with the roads department completing repairs on Laurel.

Water

- Leak detection crews were in town the week of April 22nd.
- Replaced all SCADA radios and firmware at 6 sites.
- Concrete pads were poured for three new hydrant sites. A hydrant and 12" isolation valve was installed near Coos. Two more hydrants will be installed this fiscal year.

- Repairs were made to the Howell Springs Road.
- The realignment of the Poplar Road Distribution Line project is out to bid. Construction for this project will begin July 1st.

- We have had 21 schools that we have educated on the beach, in-class presentations and virtual tidepool education. With about \$500.00 currently raised from schools.
- Summer Camps are filling fast we received a generous donation from Friends of Haystack Rock to fund scholarships for 2 slots in each camp.
- Friends of Haystack Rock donated 12 sweatshirts to be used as "ambassadors" for our program.

Wheelchairs and Bilingual Interpretations – Inclusivity – Andrea Suarez

- Total Booked: 25
- Cancelled: 3 (April 2019; all cited weather)
- Donations: \$800; \$500 given on 4/22 by a visitor whose husband was able to use the beach wheelchair last year in June 2018 to go to Haystack Rock and experience the tidepools before his untimely passing in Nov. 2018.
- Special to note:
 - Ability to make weekend reservations has been limited/cancelled; since implementing "no weekend" rule, Andrea has turned away 52 potential reservations who wanted weekend time.
 - Andrea plans to honor all weekend reservations that were made prior to eliminating weekend availabilities.
 - As of 4/23/2019, wheelchair reservations are already being reserved through October 2019.
 - Andrea has started taking the beach wheelchair to the beach during her on beach shifts, adding a jar for donations, and using the guaranteed crowds for free exposure, allowing people to see and even sit on and test out the beach wheelchair very effective.
 - The weekend of June 8, 2019 is already completely booked for the June 2019 Sandcastle Contest and parade because of the 2019 schedule that Kari produced and posted online.
 - The beach wheelchairs are starting to be used by people who want to have tidepools tours, either with Jesse Jones or with Andrea.
 - From relationships made last year, Andrea has gotten 6 return reservations from guests who used and loved the beach wheelchairs last year. Each have made more than one reservation for during their week of vacation. More are expected.
 - Andrea is currently researching beach walkers, which is something she has started to get more phone requests about. Additionally, with additional time, she could help HRAP with private tidepool tours aimed at being inclusive. Whether for Spanish speakers, or for families with someone in the beach wheelchair, this would add the personal touch that almost always results in grateful visitors and generous donations.
